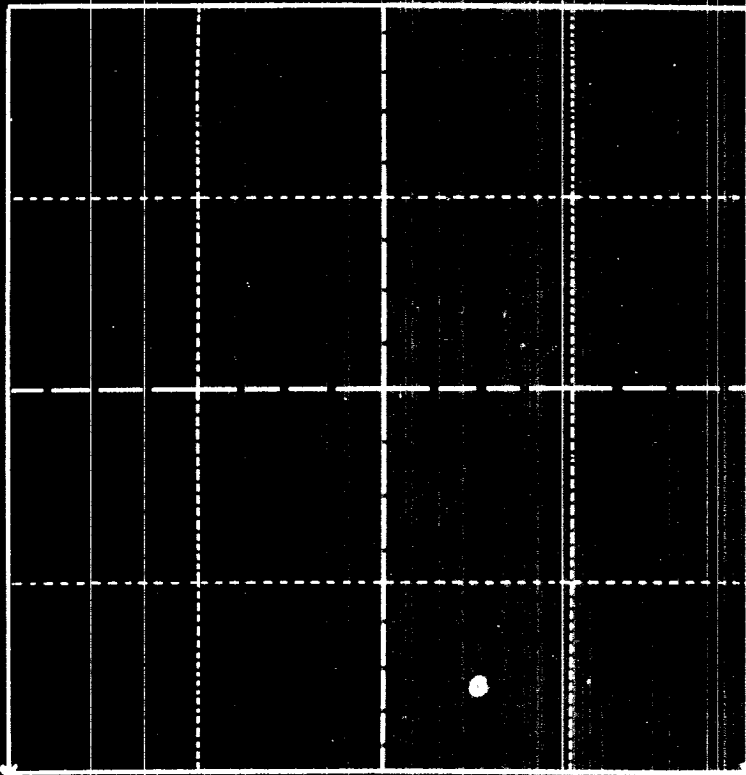
Instructions
