In accordance w/NMOCC Order No. R-4306 dated 5/19/72 we have converted this well to WIW as follows:

Plugged back 4½" OH from T.D. 3255' to 3122', w/expanding cement containing 5#/sk sand (15 sx). Set 5½" x 2-3/8" Johnson tension packer at 2889.36' w/15,000# tension. Loaded 2-3/8" x 5½" annulus w/treated fresh water. Installed surface connection & started injection 7/5/72 @ 10:00 AM. Injecting at rate of 100 BWPD at 100# pressure.
