3. Circulate hole w/mud. 100' plug 1801-1901 - TAG
4. Perforate bottom of salt at 1220' and squeeze 35 sx 100' plug from 1220'-1120' - TAG
5. Perforate top of salt at 485' and squeeze 35 sx 100' plug from 485-385' 100' plug 445'-545' inside & outside 7" & 5 1/2" csg - TAG
6. Spot 10 sx cement from 60' to surface. - inside & outside All csg. strings
7. Cut off well head and install dry hole marker.
