Well is presently producing through 4-1/2" OD casing liner perfs. 3404-3431' of the San Andres Formation.

We propose to perforate additional holes in the Grayburg Formation as follows:

1. Move in and rig up Workover Rig.
2. Pull rods and tubing.
3. Run Gamma Ray Collar Log.
4. Selectively perforate 7" OD casing and 4-1/2" OD casing liner from 3028' to 3360' for a total of 24 shots.
5. Isolate and treat through perfs. 3168-3360' (intervals) with 2,000 gallons acid and ball sealers.
6. Isolate and treat through perfs. 3028-3141' (intervals) with 1,000 gallons acid.
7. Isolate and treat through perfs. 3028-3141' (intervals) with 15,000 gallons water and 15,000# 20/40 sand.
8. Pull Retrievable Bridge Plug.
9. Run tubing and rods and return well to a producing status.

Instructions
