Water will be injected through open-hole section 3388-3660' and perforations 3181-3366' of the Grayburg & San Andres Formation.

This will be a water injection well for the Skelly Unit, operated by Skelly Oil Company.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
