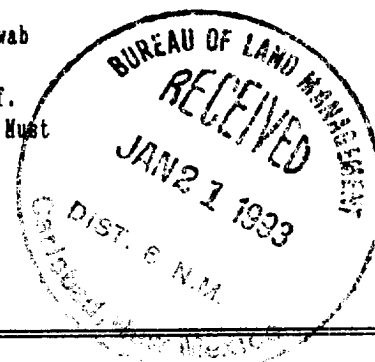

- 1.) Dig small working pit. Bleed well down. Haul excess wtr. Catch wtr samples & analyze for solids, hydrocarbons & bacteria.
- 2.) Release pkr. POH w/tbg & pkr.
- 3.) RIH w/tbg & bit or bailer.
- 4.) Clean out well to TD.
- 5.) Run cased hole logs.
- 6.) Acidize well to clean perms & remove any near well bore damage. Flow & swab back acid residue. Drain and back fill working pit.
- 7.) RIH w/plastic coated tbg & pkr. Set pkr no more than $\pm 50'$ above top perf. Place one drum of corrosion inhibitor in casing annulus & pressure test. Must hold 300# for 30 minutes.
- 8.) Place well on injection & establish injection rate.
