1. We spudded this well at 7:00 p.m. 12/31/70.
2. We ran 449' KB of 8-5/8" Surface casing and cemented with 100 sacks.
3. WOC 18 hours and tested to 500# held ok.
4. We ran 4-1/2" 9.5# production casing to 2572' and cemented with 190 sacks of cement.
5. We perforated 3 holes (2516-17) 6 holes (2545-48) 6 holes (2550-54) 2 holes (2563-64).
6. We sand fraced the Metax sand with 40,000# 20/40 sand and 40,000 gallons gelled water.
