1. Well Spudded at 3:30 P.M., 2-1-71.

2. Ran 394' KB of 8-5/8" 20# casing as follows:

a. Volume of cement equalled 132 cubic feet (100 sacks).

b. Brand of cement was Southwestern Class C with 2% CaCl.

c. Approximate temperature of cement slurry 60°F.

d. Formation temperature 65°F.

e. After standing, cemented for 9 hours compressive strength was 800#. Pressure tested to 400#. Tested OK.

f. Drilled out cement after standing 12 hours.

3. Ran 4-1/2" 9.5# casing to 3400' KB and cemented with 300 sacks of cement.

4. We perforated as follows: 4 holes (2463'-65'); 10 (2468'-73'); 6 (2493'-98'); 4 (2827'-29'); 10 (2871'-76'); 12 (2880'-86'); 6 (2983'-86'); 8 (2988'-92'); 16 (3002'-10'); 4 (3013'-15'); 24 (3110'-22'); 10 (3164'-69').

5. We sand fraced the Matex Sand with 40,000# sand and 40,000 gallons gelled water. The San Andres was fraced with 105,000# sand and 105,000 gallons gelled water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
