- 2) Ran 125 joints (3890') of 5-1/2" OD casing, of which 26 joints were 17# N-80 8R and 99 joints were 15.5# J-55. Set casing at 3899' and cemented with 500 sacks Class "C" with 2X A-2, 10# salt and 1/4# Calloflake per sack; and 200 sacks Class "C" with 10# salt per sack. Pumped plug to 3835'. Cement circulated to surface.
- 3) WOC 6 hours. Tested casing to 1500# for 30 minutes; OK.
