12/02/94 Circulate packer fluid. Found hole in casing (494' - 557').

12/03/94 Squeezed casing leak with 150 sacks Class C cement.

12/04/94 Wait on cement

12/05/94 - 12/06/94 Drilled out cement and circulated clean. Pressure still wouldn't hold.

12/07/94 RU HOWCO. Cemented casing with 500 sacks Class C cement.

12/08/94 Drilled out cement.

12/12/94 Pressure tested to approximately 520 psi for approximately 30 minutes witnessed by Don Early of the BLM (held).

Given that the integrity of the casing of the subject well is intact, Texaco Exploration and Production respectfully requests temporary abandonment status. The Lea C and the Lea D leases will be sold to a different operator effective January 1, 1995.
