Presently, this well is producing from the Upper Queen through an open hole interval between 3310' and 3627' (TD = 3627'). Devon Energy plans to deepen this well to 4000' to test the Lower Queen formation. A 6 1/4" hole will be drilled to 4000' and logged. If sufficient porosity development is present, a 4 1/2" liner will be set at 4000' (top of liner to be at 3160') and cemented with 100 sx Class "C" cement containing 3% salt, a fluid loss additive and 1/4 lb/sk cellophane flakes. The Lower Queen formation will then be perforated and tested. After testing the Lower Queen, the Upper Queen will be perforated, treated and returned to production.
