We plugged back to 2710, ran 2702' 7" seamless casing cemented (Denton) with 50 sacks. Let set 72 hours. Gun perforated (Lane-Wells) 40 shots 2667' to 2779' broke down formation at 2000 lbs down to 1400 lbs. Took 10,000 gal. Famaris oil and 20,000 lb. sand at 16 bbs. per minute. now installing pumping equipment to pump.
