2. Perforated 5-1/2" casing w/1 JSPF from 2693-2771'.
3. Acidized w/500 gals 15% NEA. Frac w/3000 gals gelled brine w/1# 20/40 sand/gal. Preceded frac w/2000 gals gelled brine pad and flushed w/1500 gals gelled brine.
4. On 24 hr. potential test 1-15-73. Pumped 3 Bbls. oil, 61 Bbls. water. GOR TSTM, Gravity 33.7.

Instructions
