## DETAILS OF WORK

It is proposed to drill this well to approximately 3950' with rotary tools to test formations down to the Grayburg. It is proposed to cement 8-5/8" casing at approximately 260 feet and bring cement back to the surface. Oil string will be 5 1/2" casing set near bottom and cemented back to the top of salt. Well will be completed by perforating casing and treating with sand-oil frac.

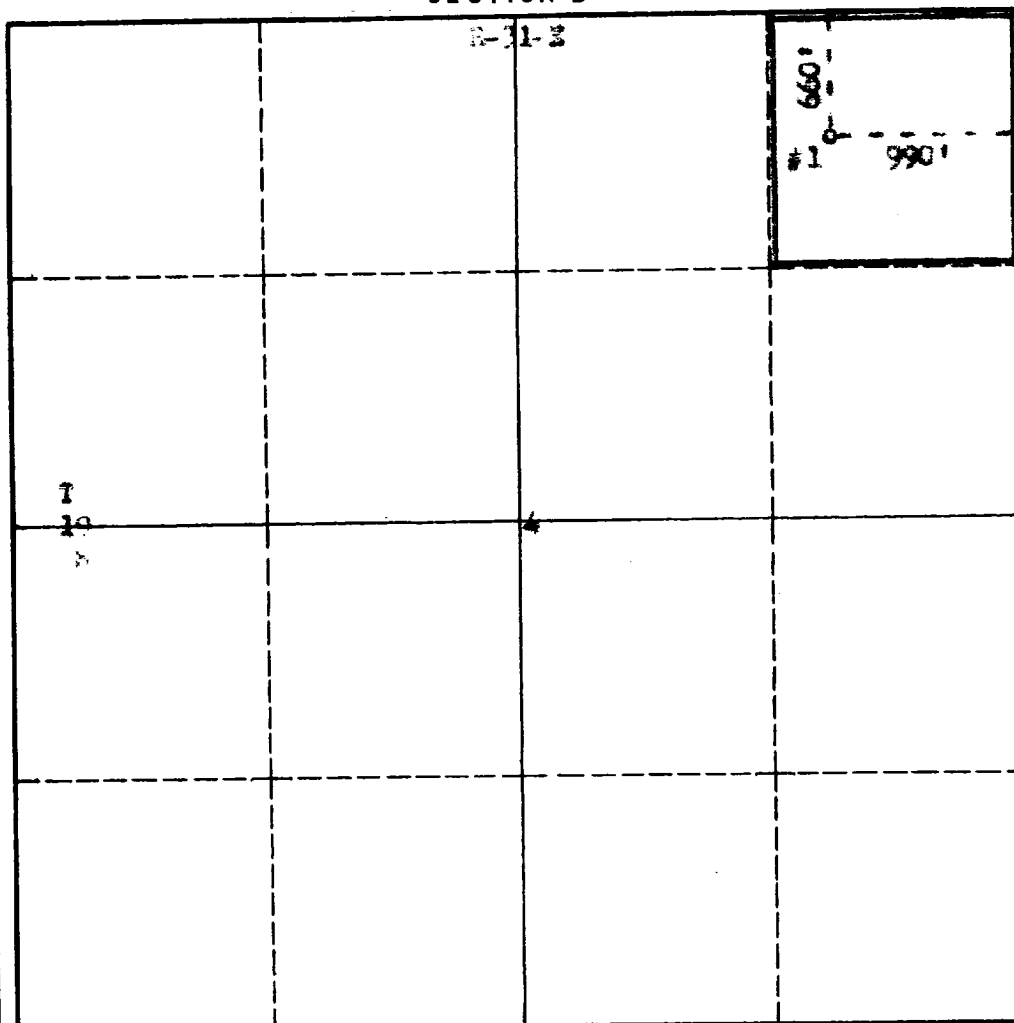
