Propose to recomplete well in Yeso as follows: Unseat packer at 4196' and TOH w/injection tubing and packer. RIH w/cement retainer, set at 4050', establish injection rate into Abo perms. Squeeze Abo perms w/200 sx Class "C" Neat. Perforate the Yeso 2253-2379' (17 holes) and 2049-2147' (17 holes). Will acidize and frac as necessary to obtain production. (New Form C-102 Attached.)


