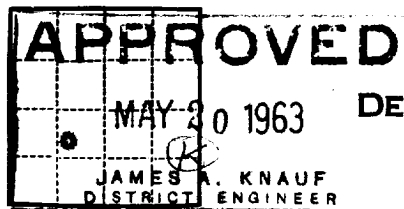

Cementing program: Cement 13-3/8" casing to surface.
Cement 8-5/8" casing to surface.
Cement 5-1/2" casing to 7000'.
