Procedure:

1. Set 5-1/2" CIBP @ 3300' and cap with 35' of cement.
2. Cut and pull 5-1/2" casing as deep as possible.
3. Spot 35 sxs of cement @ stub and tag. (150' minimum)
4. Spot 50 sxs of cement @ 800-699'. (tag plug)
5. Spot 10 sxs of cement @ surface.
6. Install dry hole marker.
