We propose to plug and abandon this well as follows: Spot a 35 sack cement plug through tubing over the interval from 2590' to 2500' (top of San Andres) Spot a 35 sack cement plug through tubing over the interval from 1620' to 1710' (top of Queen-Grayburg) Pull 10 3/4" casing now set at 235'. Spot a 25 sack cement plug through tubing over the interval from 220' to 180'. Spot a 25 sack cement plug through tubing from 30' to surface and erect a marker.
