Well was temporarily abandoned from 2/19/71 to 9/10/71 after acidizing and swab testing. No oil recovered.

9/10/71 Sand fraced via casing with 40,000 gallons sand and 40,000 gallons treated brine. Maximum pressure = 2,100#; Minimum pressure = 1,600#. AIR 20 BPM Shut well in waiting on test unit and test tank.

10/01/71 Sand pumped well to PBTD 3,540'. Ran 2 3/8" EUE tubing set at 3,350'. Ran 3/4" rods with 2" x 1 1/2" x 12' insert pump.

10/01/71 to 11/11/71.....tested well. Fluid 100% water....no oil!

11/11/71 24 hour test - trace of oil and 80 barrels water. Shut well in on this date.

REQUEST permission to leave well shut in for 6 month observance period of possible waterflood response.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
