Your Notice of Intention to Drill well No. 1-20 Federal "HY" (copy attached) in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ sec. 20, T. 19 S., R. 31 E., N.M.P.M., Eddy County, New Mexico, lease New Mexico 04097, to a depth of 2,200 feet to test the Yates formation, has been forwarded to this office for approval.

Pursuant to authority delegated to the Regional Oil and Gas Supervisor on May 10, 1962, 27 F.R. 4814, I hereby approve the Notice of Intention to Drill described in the foregoing subject to the following conditions:

1. Drilling operations so authorized are subject to the attached sheet for general conditions of approval.
2. A daily progress report is to be furnished in duplicate from spud date until completion of the well.
3. Drilling rig must not be moved from well without prior approval from the Survey (30 CFR 221.34c).

If the lease is to be considered for extension by diligent drilling operations, the lease rental must be timely paid.

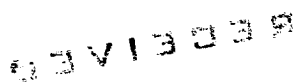
