Ran 33 jts., 36#, J55, 9 5/8" casing. Set at 1065' KBM. Cement first stage with 240 sxs. Incor neat cement plus 2% CaCl. DV tool set at 550'. Plug down at 8 P.M. 2/19/65. Circulated approx. 4 bbls. cement above DV tool. Second stage 2 A.M. 2/20/65 with 360 sxs. Posmix plus 2% gel. Plug down 2:30 A.M.
Ran Temp survey at 9 A.M. 2/20/65 Top of cement 125 feet. Ran 1 inch pipe to 125 feet, cemented with 250 sxs. neat cement to surface. Finished cementing at 2 P.M. Cut off casing. Started nipping up at 8 P.M. Cement petal baskets set at 713, 538, 356, 195, and 125'. Pressured casing with 1000#. Held OK. Drilled out from under casing with air.
