On January 26, 1969 we ran 805' of 8-5/8" Casing and cemented with 50 sacks.
On April 2, 1969 ran 3935' of 5 1/2" Casing & Cemented with 100 sacks. Shut down 72 hours after running each string and found complete shutoff.

On April 7, 1969 ran Electric Log and perforated 5 1/2" casing from 3875 to 3887 with 36 holes. On April 8, 1969 treated through above perforations with 750 barrels of lease oil and 30,000# of sand.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
