Propose to temporarily abandon this well for future use in secondary recovery efforts as follows:

POOH with tbg and downhole equipment.

Set CIBP at 7605', over the Canyon perms. Cap with 35' cement.

Set CIBP at 6654', over the Wolfcamp perms. Cap with 35' cement.

Load hole with 2% KCl water with 1 gpt corrosion inhibitor.

Notify BLM in Carlsbad with 24 hour notice to witness pressure casing test.

Notify OCD in Artesia with 24 hour notice to witness pressure casing test.

Pressure test casing to 500 psi and record chart for 30 minutes. Submit chart to BLM.

If casing fails pressure test, need decision on whether to look for holes or plug and abandon.
