1. MIRU pulling unit.
2. NU BOP's.
3. RIH & drill out cement to 8495'. Tested casing to 1000 psig.
4. Run GR-CBL-CCL from 8495'-2441'. Good bond across zone of interest.
5. Perf Second Bone Spring Carbonate w/3 3/8" casing gun f/8041'-8170' w/2 JSPF (total 259 holes).
6. Acidized Second Bone Spring Carbonate f/8041'-8170' w/8200 gals gelled 20% NEFE HCl dropping 225 ball sealers for diversion.
7. Swabbed well in.
8. On 8-22-90 well potential tested flowing 280 BOPD, 0 BWPD and 276 MCFGPD on 20/64" choke w/FTP 275 psig.
