DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was plugged as follows:

Cement plug was put in bottom of hole, using three sacks of cement, which cemented about fifteen feet of the six-inch hole.
Heavy mud was run from top of the cement plug to 390 ft.
Cement plug was put at 390 ft., using three sacks of cement.
Heavy mud was put in hole from top of the plug to top of hole.
