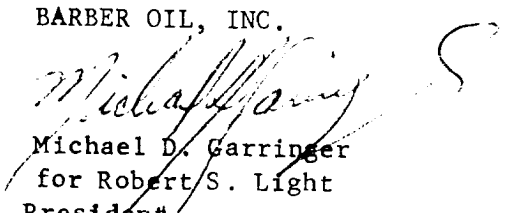
Mike Williams of the Artesia office of the Oil Conservation Division was in my office this morning and informed me their records show Well Number 3 in the above captioned property as an injection well. We are aware that some time ago Mr. George D. Riggs (previous operator) had filed with the OCC an intention to convert the well from production to injection. The well name and number at that time was the Hughes Federal #4. The well was never converted to injection and to this day is a producing well. Therefore the enclosed reports, Form 9-331 do not describe any proposed action to convert to a producing well.

We are not aware of the status of the well in the U.S.G.S. records. Therefore, we are sending these reports so that if your records are in error they can be corrected. If your records do not show the well as an injection well you may simply throw the reports away.

In conclusion, Well #3 of the Saladar Unit is now and has always been a producing well.
