Set Baker plug in on & off Tool in Packer at 13270 to shut off Morrow - Tested to 3000# surface pressure. Unjayed Guiberson dual packer and pulled 2 7/8" & 2 1/16" tubing Perforated Atoka from 12326-33 & 12870-74 @ 1spf. Set Baker packer @ 12777 and ran back in hole single string of tubing - 2 7/8" DSS tubing and set @ 12783. Commenced swabbing operations. Preparing to test well in Atoka for AOF.
