4. Set plug at 9822' above Morrow "A" Zone.
5. Perforated Morrow Ross sand from 9784'-90' K.B.
6. Ran Otis packer to 9748' on 2 7/8" N-80 tubing.
7. Tested well at 2.66 MMCFPD on an 18/64" adjustable choke with 2000#-flowing tubing pressure.
