MI & RU DDU. COOH w/rods & pump. Install BOP. GIH w/tbg. & tag bottom PTD (2186'). Displace csg. w/9.5 ppg mud laden fluid. COOH w/tbg & mud anchor. GIH open ended to PTD. Lay a balanced plug w/50 sxs of Class C cmt. w/2% CaCl₂ (mixed @ 14.8 ppg, yld 1.32 cf/sk) from 2186' to 1950'. This will cover the 5-1/2" csg. shoe, Yeso perf. & the 8-5/8" csg. shoe. PU tbg. to 260' & reverse circ. clean. WOC, tag & record TOC. Min. TOC to be 1950'. Perf. the 5-1/2" csg. at 260' w/4 SPF. COOH. Est. injection rate & pressure. Bullhead down 5-1/2" csg. 70 sxs Class C cmt. (mixed as above) & circ. 5-1/2" x 8-5/8" annulus to surface. This plug will cover the 13-3/8" shoe & surface plug. Cut off CHF. Weld on 1/2" plate for abandonment. Fill in hole & clean up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
