It is planned to plug back the existing Upper Penn perforations at 8306'-8348' by setting a CIBP @ 8290' and dump bailing 20' of cement on top. The Upper Penn will then be perforated w/ a 4" casing gun & 2 JSPF from 8008'-8233' (132 shots). New perms will then be treated w/ 8000 gals 15% HCl acid and the well returned to production.

This work will begin on approximately January 15, 1996.
