Marathon Oil Company initiated completion operations to complete the Upper Penn/Morrow in the above referenced well on 5-11-90. Following is the procedure:

1. MIRU pulling unit.
2. Installed BOP's.
3. Loaded csg & tested to 1200 psig.
4. RIH w/bit, DC's. & 2 7/8" tbg to 6732' & tagged cement. Drilled out to 6808' & tagged DV tool. Drilled out DV tool. Reversed hole clean. Tested pipe rams & DV tool to 1200 psig. FIH w/2 7/8" tbg & tagged cement @ 9190'. Drilled out to 9213' & tagged float collar. Drilled out float collar & cement to 9247'. Reversed hole clean. Tested pipe rams & float collar to 1200 psig.
5. POOH w/tbg, drill collars & bit.
6. RIH w/bit, casing scraper & tbg to 9247'. Circulated hole w/220 bbls 2% KCl water. POOH w/tbg, casing scrapers & bit.
7. RU Loggers.
8. Ran GR-CBL-CCL from PBTD 9251'-7200'. Good to fair bond across U. Penn & Morrow. Reran log w/1000 psig from 9251'-1800'. Good bond across U. Penn & Morrow, good bond 7200'-5600', poor to fair bond 5600'-1800'. POOH w/logging tools & RD Loggers.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
