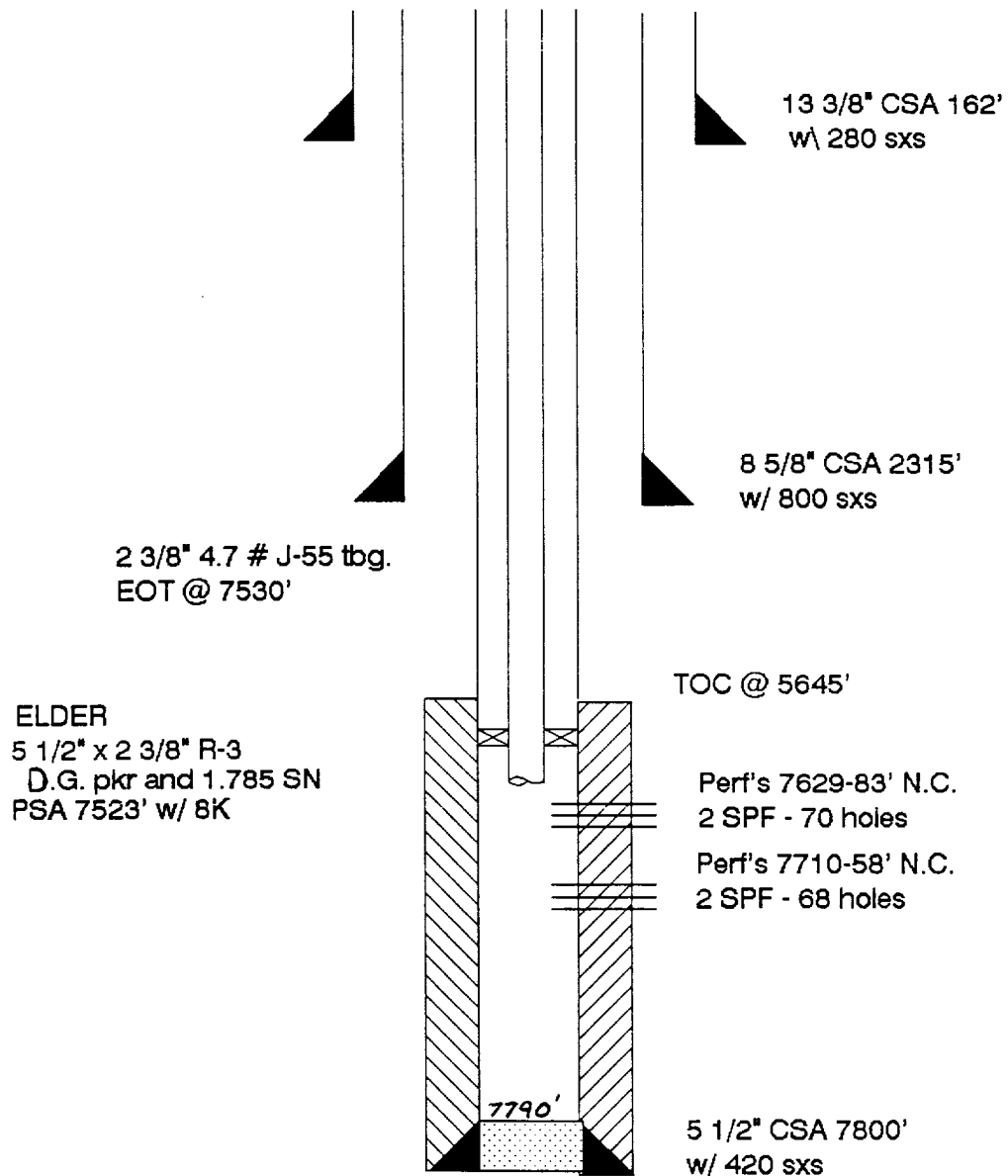

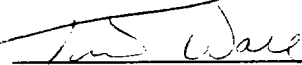

- 1) MIRU workover unit. Bleed pressure off tbg.
- 2) Release packer, allow well to stabilize. POOH w/ tbg and packer. LD packer.
- 3) PU and TIH w/ CIBP. Set BP at +/- 7550'.
- 4) Pressure test wellbore to 500#
- 5) Wellbore test OK. Circulate wellbore clean with treated fluid.
- 6) POOH and LD tbg.
- 7) Secure well. Well temporarily abandoned.
