- The oil is sold to Amoco and trucked out from the Dall Federal Tank Battery.
- The gas is transported through LDNG's gas lines to LDNG's Happy Valley Compressor Station. The gas is then sold to Highlands Gas Corp. through a meter located at NE/SW Sec. 15, T-23S, R-26E, Eddy Co., N.M.
- The water is hauled out by Scurlock Permian to a State approved disposal well.
