TD 1616'. Reached TD at 9:30 PM 3-24-2000. Ran 36 joints of 9-5/8" 36# J-55 (1620') of casing set at 1616'. 1-regular guide shoe set at 1616'. Float collar set at 1571'. Cemented with 200 sacks Thixotropic, 1/4#/sack celloflake and 10#/sack gilsonite (yield 1.50, weight 14.6) and 800 sacks 65-35 Poz C, 5#/sack salt, 1/4#/sack celloflake, 5#/sack gilsonite and 6% gel (yield 2.04, weight 12.5). Tailed in with 200 sacks "C" with 2% CaCl2 (yield 1.34, weight 14.8). PD 4:45 AM 3-25-2000. Bumped plug to 1000 psi, OK. Circulated 388 sacks. WOC. Nippled up and tested BOP to 3000# for 15 minutes, OK. Drilled out at 8:15 AM 3-26-2000. WOC 27 hours and 30 minutes. Reduced hole to 8-3/4". Resumed drilling.

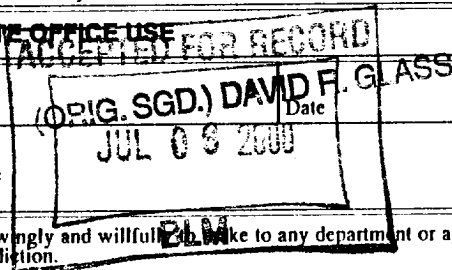
