5/07/96: Set plug in 1.78" profile in on-off tool @ 11,293'. Test plug to 3000 psi, held ok. Morrow perfs 11,407' - 11,668' plugged off.

5/08/96: Run CBL 9,500'-10,500'.

5/09/96: Spot 500 gals 15% NEFE HCl @ 10,074'. Set pkr @ 9,901' & test casing to 500 psi. ND BOP, NU tree and shut well in.

5/10/96: Swab FL down in tbg to 7,000' from surface. Perforate Strawn @ 10,068'-10,074' w/ 1-11/16" strip gun, 2 SPF (14 holes), no response. Load tbg w/ 27 bbls 2% KCl water and pump 500 gals of spot acid away. Break down @ 3,450 psi, 1 BPM, max pressure 4,810 psi @ 3.3 BPM. Have 54 bbls of load to recover. Made 12 swab runs, rec 59 bbls water w/ slight blow on tbg. Initial FL @ surface. FFL @ 511'.

5/11/96" Pmp'd 2500 gals 15% HCl. Flow back 15 bbls. Made 12 swab runs to 4,000', rec 85 bbls. Picked up heavy mud and/or cement on last 2 runs.
