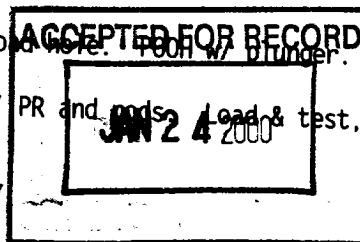

12/4/99 RIH w/ 2 1/2" X 2" X36" RHBC pump, lift sub, 26K shear tool, 30' PR and rods. Load & test, RD.
