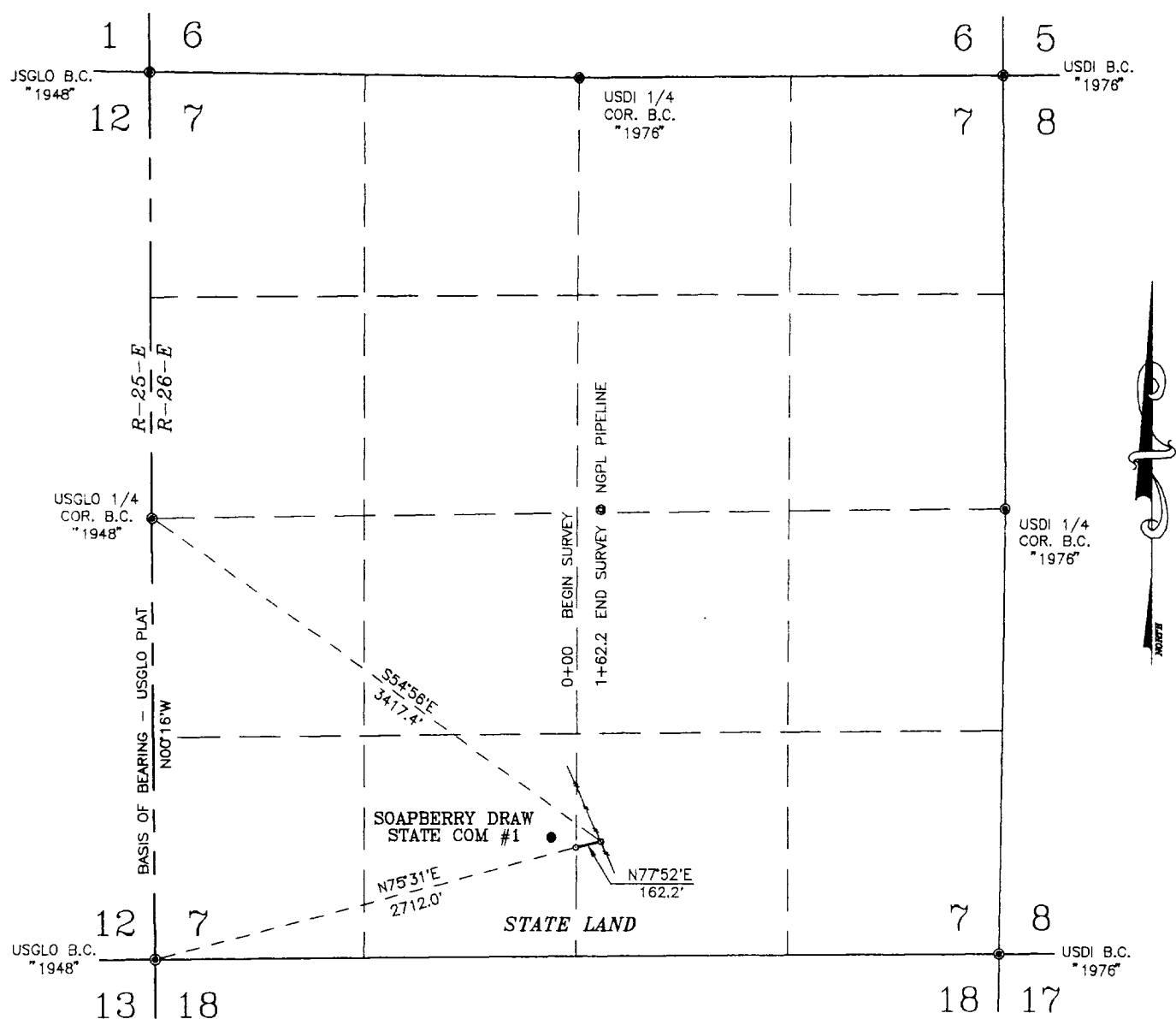

Proposed Pipeline ROW

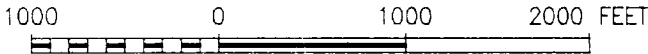
LEGAL DESCRIPTION

A STRIP OF LAND 30 FEET WIDE CROSSING STATE OF NEW MEXICO LAND IN SECTION 7, TOWNSHIP 21 SOUTH, RANGE 26 EAST, N.M.P.M., EDDY COUNTY, NEW MEXICO AND BEING 15.0 FEET LEFT AND 15.0 FEET RIGHT OF THE FOLLOWING DESCRIBED CENTERLINE SURVEY:

BEGINNING AT A POINT IN THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 7 WHICH LIES N75°31'E - 2712.0 FEET FROM A USGLO BRASS CAP FOUND AT THE SOUTHWEST CORNER OF SAID SECTION 7; THENCE N77°52'E - 162.2 FEET TO AT A POINT IN THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 7 WHICH LIES S54°56'E - 3417.4 FEET FROM A USGLO BRASS CAP FOUND AT THE WEST QUARTER CORNER OF SECTION 7.

SAID STRIP OF LAND BEING 162.2 FEET OR 9.83 RODS IN LENGTH AND CONTAINING 0.112 ACRES, MORE OR LESS, AND BEING ALLOCATED BY FORTIES AS FOLLOWS:

SE/4 SW/4 - 0.27 RODS - 0.003 ACRES  
SW/4 SE/4 - 9.56 RODS - 0.109 ACRES
