Per the attached permit, this previously approved well is to be drilled in the very near future (planned spud - early November) as a dual completion in the Indian Basin Upper Penn and Loafer Draw Morrow pools. The well was previously permitted and approved at a surface location of 1880' FSL & 1980' FWL. The purpose of this letter is to explain the circumstances requiring movement of the proposed surface location and to convey ChevronTexaco's intent and plan to ensure an orthodox location prior to entering the Morrow formation.

Due to topographic, archeological, and surface facility concerns, the most acceptable location in the SW quarter of the section 33 from which to drill is 1980' FSL & 2080' FWL. A similar bottom hole location would be orthodox for the Indian Basin Upper Penn pool but would be unorthodox for the Loafer Draw Morrow pool (statewide rules). In order to achieve an 'orthodox location' status in both pools and a higher structural penetration point within the Morrow reservoir, it is our intent to steer the well, prior to the Morrow reservoir penetration point, to a subsurface location at a maximum distance of 1980' FSL & 1980' FWL. Survey data will be provided to verify this result.

Due to our rig commitment, limited time prior to the planned spud date and significant dirt work required prior to move in, ChevronTexaco would greatly appreciate your prompt attention to this permit request. 


