On October 28, 1992 we set 4416' of 8 5/8", 32 ppf ST&C intermediate casing in an 11" open hole. The casing was cemented to surface with the following slurries:

1. 2200 sks 35:65 (Poz:Class C) + 6% gel + 15% salt + 0.25 #/sk cellophane flake
2. 200 sks Class C + 2% CaCl2 + 0.25 #/sk cellophane flake

We circulated 614 sks of cement to the pit. The BLM was notified and a witness was present when we ran pipe and cemented (Don Earley).
