- 11/29/92 Fractured the Delaware perfs with 39,146 gals gelled water + 35,000 lbs sand. The well was opened to the pit and test tank immediately following the frac for forced closure.
- 11/30/92 Currently recovering load and testing. Test results will be submitted per Form 3160-4 as soon as they are available.
