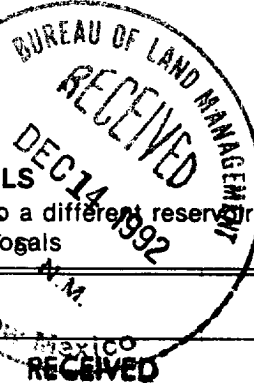

This well was perforated and stimulated in the Delaware as follows:

12-2-92 Perforated the Delaware from 7944'-8035' (1 spf). The perfs were acidized with 2500 gals 15% HCl acid and 150 ball sealers.

12-3-92 Fractured the Delaware perfs with 51,750 gals gelled 2% KCl water and 60,500 lbs 20/40 sand. The well was opened to the pit and test tank for forced closure immediately following the frac.

12-10-92 Currently recovering load and testing. Test results will be submitted per Form 3160-4 as soon as they are available.
