On 10/5/92, we set 850' of 13 3/8" 48# ST&C surface casing in a 20" open hole. We pumped the following slurries:

Lead Slurry = 600 sks 65:35 (Class H:Poz) +6% gel + 2% CaCl₂

Tail Slurry = 200 sks Class C + 2% CaCl₂

Cement was circulated to surface (circulated 35 sks). No BLM representative was on location to witness the procedure.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
