On 10/20/92 we set 8400' of 5 1/2" 15.5 and 17.0 ppf, LT&C production casing in a 7 7/8" open hole. The production casing was cemented in two stages with a DV tool set at 5839'. We pumped the following cement slurries:

1st Stage = 600 sks Silica Lite + 3% salt + 0.6% Fluid Loss Additive + 0.25 lb/sk cellophane flake

2nd Stage = 450 sks 35:65 (Poz:Class C) + 6% Gel + 0.25 lb/sk cellophane flake (lead)
100 sks Class C neat (tail slurry)

The 1st stage circulated cement to the pit (160 sks). Estimated top of cement = 3000' on the 2nd stage. The BLM was notified prior to pumping, but no witness was present.
