This new well was perforated and stimulated in the Delaware as follows:

11/6/92 The Delaware was perforated from 8170' - 8210', 1 jet shot per foot. The perforations were acidized with 2200 gals NEFE HCl acid and 60 ball sealers. The well was swabbed down and shut-in waiting on the frac.

11/9/92 A minifrac was pumped and a temperature survey was run to determine fracture height growth. The fluid was swabbed back and the well was shut-in overnight.

11/10/92 The Delaware formation was fracture stimulated with 33,000 gals gelled 2% KCl water + 21,500 lbs 20/40 mesh sand + 10,000 lbs 20/40 resin coated sand. Forced closure flowback was initiated immediately following the frac.

11/11/92 Currently recovering load water. Well will be tested. Test results will be submitted per Form 3160-4 as soon as they are available.
