We spudded this new well at 1830 hrs. on 12/12/92. On 12/13/92, we set 850' of 13 3/8" surface casing in a 17 1/2" open hole. We cemented the casing with:

450 sks 35:65 (Poz:ClassH) + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes
200 sks Class C + 2% CaCl2 + 1/4 lb/sk cellophane flakes

Cement was circulated to surface (70 sks). The BLM office in Carlsbad was notified prior to the job.
