On 11/16/92 we set 4,350' of 8 5/8" intermediate casing (32 ppf, WC50) in an 11" open hole. The casing was cemented with the following slurries:

2,000 sks 35:65 (Poz:Class C) + 6% gel + 15% salt + 1/4 lb/sk cellophane flakes

200 sks Class C + 2% CaCl<sub>2</sub> + 1/4 lb/sk cellophane flakes

Cement was circulated to surface (216 sks). The BLM was notified prior to the job.
