We plan to perforate additional Delaware in this well. The Middle Brushy Canyon 'C' zone will be perforated from 7588' - 7610', 1 spf (12 holes) with a 4" casing gun. The new perfs will be acidized with 750 gals 7 1/2% NEFE acid + 30 ball sealers. We will swab back the load and frac with 16,000 gals(+) gelled 2% KCl water and 34,500 lbs 16/30 sand. The load will be recovered and the production will be commingled with the present Lower Brushy Canyon 'A', 'B', 'C' and 'D' intervals. The well will be beam pumped.

On 6/7/93 at 9:15 a.m. (CDT) we received verbal approval from BLM Petroleum Engineer Adam Salameh to proceed with this work. A subsequent report will be filed upon completion of the work.
