The Middle Brushy Canyon perfs from 7588'-7610' (12 holes) that were opened and completed in June 1993 were cement squeezed. On 7/27/93, we pumped 150 sx Class "C" cement via 2 7/8" tubing and packer set at 7283'. The squeeze was pressure tested to 1500 psi and held. Currently, the well is waiting on the Upper Brushy Canyon completion.
