On 7/31/93, we perforated the Upper Brushy Canyon "E" zone from 7026'-7054' with a 4" casing gun (1 sp2f, 15 total holes). The perfs were acidized the following day with 750 gals 7 1/2% NEFE acid and 30 ball sealers. On 8-3-93, the perfs were fraced with 21,250 gals gelled 2% KCl water + 31,500 lbs 16/30 sand and 12,000 lbs 16/30 resin coated sand. The well was flowed back immediately following the frac for forced closure. Currently, we are testing the well.
