On 3/17/93, we set 8350' of 5 1/2" casing in a 7 7/8" open hole. The casing was cemented in two stages with a DV tool set at 5712'. We pumped the following cement slurries:

1st Stage: 550 sks Silica Lite + 3% salt + 0.6% fluid loss additive + 1/4 lb/sk cellophane flakes (circulated 175 sks to the pit)

2nd Stage: 200 sks 35:65 (Poz:Class C) + 6% gel + 1/4 lb/sk cellophane flakes

500 sks Class C + 4% gel

Estimated top of cement = 2500'. (Casing weight = 15.5 and 17.0 ppf, K-55)
